The contractor should be identified by a valid membership of the Palestinian Contractors' Union. The tender documents will be handed to persons only upon presenting a written authorization together with the seal of the company/firm for non-refundable tender fees **USD50 for each lot**. The method of paying tender fees will be Bank Deposit to the **UNRWA current account No. 515700, UNRWA – GFO, Bank of Palestine**. Tender's name and number should be appeared on the receipt voucher.

Each tender shall be accompanied by an unconditional, irrevocable and not be restricted bank guarantee of **(USD 10,000)** for each lot as security deposit and valid for **(120)** days from the tender closing date and made available to UNRWA.
